

**NOTICE OF SECOND PUBLIC HEARING**

The **Paulding County Board of Commissioners** intends to apply to the Ohio Department of Development: Office of Community Development (OCD) for federal grant funding. Grant funding is available through the Federal Department of Housing and Urban Development’s (HUD) Community Development Block Grant Program (CDBG), which the OCD administers.

On 1/18/2023, the first out of two mandatory public hearings for the federal CDBG Program, Program Year 2023 were conducted. The purpose of “Public Hearing #1” was to inform citizens and community officials about potential grant funding sources within that grant program for program year 2023.

Public Hearing #2 will be held on **Wednesday, May 3, 2023 @ 9:00 am** at the **Paulding County** Commissioners Office at 451 McDonald Pike, Suite E, Paulding, OH 45879. The purpose of this public hearing is to provide the public with an opportunity to review and comment on the following proposed projects prior to submission for funding from the federal CDBG Program, Program Year 2023:
